Resolution authorizing the San Francisco Department of Public Health (SFPDH), to accept retroactively and expend a grant in the amount of \$172,882 from the Centers for Disease Control and Prevention (CDC) for HIV risk behavior surveillance among men who have sex with men and to enter into an agreement for the use of these funds; for the period of September 30, 2003, to September 29, 2004.

WHEREAS, SFPDH has applied for and been awarded a grant from CDC in the amount of \$172,882 for the first year of three years for HIV risk behavior surveillance among men who have sex with men; and,

WHEREAS, As a condition of receiving the grant funds, CDC requires the City to enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. 031843, which is hereby declared to be a part of this resolution as if set forth fully herein; and,

WHEREAS, The grant budget includes provision for indirect costs of \$11,128; and,

WHEREAS, This Resolution requires expedited review by the Board of Supervisors because we did not receive the grant award notice until September 15, 2003; and,

WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds may be placed automatically on the consent agendas in committee, as they are usually considered to be routine items, and this resolution authorizes the acceptance and expenditure of grant funding; now, therefore, be it


RESOLVED, That SFPDH is hereby authorized to accept retroactively and expend a grant in the amount of \$172,882 from CDC; and, be it

1 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the
2 grant funds in accordance with the requirements set forth in the Agreement pursuant to San
3 Francisco Administrative Code section 10-170-1; and, be it

4 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
5 agreement on behalf of the City; and, be it



6 FURTHER RESOLVED, That the Controller is directed to designate the positions
