4 **Resolution authorizing the San Francisco Department of Public Health (SFDPH), to**
5 **accept retroactively and expend a grant in the amount of \$393,478 from the Centers for**
6 **Disease Control and Prevention (CDC) to use rapid HIV testing to improve outcomes in**
7 **partner counseling and referral services and to enter into an agreement for the use of**
8 **these funds; for the period of September 15, 2003, to September 14, 2005.**

10 WHEREAS, SFDPH has applied for and been awarded a grant from CDC in the
11 amount of \$393,478 to demonstrate the use of rapid HIV testing to improve outcomes in
12 partner counseling and referral services; and,

13 WHEREAS, As a condition of receiving the grant funds, CDC requires the City to enter
14 into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of
15 Supervisors in File No. 031856, which is hereby declared to be a part of this
16 resolution as if set forth fully herein; and,

17 WHEREAS, The grant budget includes provision for indirect costs of \$54,273; and,

18 WHEREAS, This Resolution requires expedited review by the Board of Supervisors
19 because we did not receive the grant award notice until September 11, 2003; and,

20 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds
21 may be placed automatically on the consent agendas in committee, as they are usually
22 considered to be routine items, and this resolution authorizes the acceptance and expenditure
23 of grant funding; now, therefore, be it


24 RESOLVED, That SFDPH is hereby authorized to accept retroactively and expend a
25 grant in the amount of \$393,478 from CDC; and, be it

1 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the
2 grant funds in accordance with the requirements set forth in the Agreement pursuant to San
3 Francisco Administrative Code section 10-170-1; and, be it

4 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
5 agreement on behalf of the City; and, be it


6 FURTHER RESOLVED, That the Controller is directed to designate the positions
7 funded under this agreement as "G" or grant-funded positions which would terminate when
8 the agreement expires.




