11 WHEREAS, The City Planning Department has verified that the area is properly  
12 zoned; and,

13 WHEREAS, The Police Department recommends that the liquor license  
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business  
16 and Professions Code, the Board of Supervisors of the City and County of San  
17 Francisco hereby determines for the foregoing reasons that the transfer of a Type 20  
18 off-sale beer and wine license from 1162 Folsom Street to 236 8<sup>th</sup> Street for Celeste  
19 Tonogbanua for The Gifted Basket, will serve the public convenience and necessity of  
20 the people of the City and County of San Francisco.

21 Conditions: 1) Sales and service of alcoholic beverages shall be permitted only  
22 between the hours of 8:00 a.m. and 6:00 p.m.; 2) The petitioner(s) shall be responsible  
23 for maintaining free of litter the area adjacent to the premises over which they have  
24 control; 3) Sales of alcoholic beverages shall be restricted to alcoholic beverages that  
25 are included in a gift basket.


