3 **Resolution appointing Linda M. Yu Bien (residency requirement waived), term ending**  
4 **January 15, 2007 to the San Francisco Health Authority.**

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
7 does hereby appoint the hereinafter designated person to serve as a member of the San  
8 Francisco Health Authority, pursuant to the provisions in the Welfare and Institutions Code  
9 Sec. 14087.36 and the San Francisco Administrative Code Sections 69.1 et seq., for the term  
10 specified:

11 Linda M. Yu Bien (residency waiver required), succeeding Sophie Wong, term expired,  
12 Seat No. 6, must be an employee in the senior management of either private nonprofit  
13 community clinics or a community clinic consortium, nominated by the SF Community Clinic  
14 Consortium or any successor organization for a 3-year term ending January 15, 2007.

15 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 16 1. The membership of the San Francisco Health Authority has a goal to be  
17 representative of the diversity of the City and County of San Francisco.
- 18 2. Applicant Linda M. Yu Bien, a new appointee, who is not a resident of San  
19 Francisco, is a person with experience that uniquely qualifies him/her to serve on  
20 the San Francisco Health Authority.
- 21 3. The San Francisco Health Authority has attempted to fill the position, for which  
22 Linda M. Yu Bien was nominated, with an individual who is a City resident and who  
23 has the specific experience, skills, and qualifications, but has been unable to do so  
24 at this time. The Rules Committee has certified that Linda M. Yu Bien is qualified to  
25 serve on the San Francisco Health Authority.

1 4. After exercising due diligence, the Board of Supervisors concludes that there is no  
2 other possible representative, who is a resident of San Francisco and who has the  
3 specific experience, skills, or qualifications possessed by this applicant, and who is  
4 willing to serve on the San Francisco Health Authority at this time; and, be it

5 FURTHER RESOLVED, That the Board of Supervisors waives the residency  
6 requirement for Linda M. Yu Bien, as allowed in cases where no qualified City resident, willing  
7 to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)  
8 appointed to boards, commissions, and advisory bodies established by legislative act of the  
9 Board of Supervisors to be resident(s) of the City and County of San Francisco.
