5 RESOLVED, That, pursuant to the provisions of the California Vehicle Code, the  
6 following intersections are hereby designated as "STOP" intersections, and the Department of  
7 Parking and Traffic is hereby authorized and directed to cause "STOP" signs to be installed  
8 thereat as designated below:

9 **STOP SIGNS - ESTABLISH**

10 Lincoln Way, Martin Luther King Jr. Drive, and La Playa Street, stopping Lincoln Way, making  
11 this intersection an All-Way STOP.

12 Great Highway and John F. Kennedy Drive, stopping The Great Highway, making this  
13 intersection an All-Way STOP.

14 Fulton and La Playa Streets, stopping Fulton Street, making this intersection an All-Way  
15 STOP.

16 47th Avenue and Fulton Street, stopping Fulton Street, making this intersection an All-Way  
17 STOP.

19 Categorically exempt from Environmental Review Class  
20 1(c)(9) changes in the traffic and parking regulations  
21 where such changes do not establish a higher speed  
22 limit or result in more than a negligible increase in the  
23 use of the street.




