3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**
4 **accept retroactively and expend a grant in the amount of \$699,028 from the Substance**
5 **Abuse and Mental Health Services Administration (SAMHSA) to provide supportive**
6 **services to newly housed people with disabilities and to enter into an agreement for the**
7 **use of these funds; for the period of September 30, 2003 to September 29, 2004.**

9 WHEREAS, SFDPH has applied for and been awarded a grant from SAMHSA in the
10 amount of \$699,028 to provide supportive services to newly housed formerly homeless people
11 with disabilities; and,

12 WHEREAS, As a condition of receiving the grant funds, SAMHSA requires the City to
13 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the
14 Board of Supervisors in File No. 040128, which is hereby declared to be a part of
15 this resolution as if set forth fully herein; and,

16 WHEREAS, The grant budget includes provision for indirect costs of \$33,287; and,

17 WHEREAS, This Resolution requires expedited review by the Board of Supervisors
18 because the grant agreement was not available until after the grant start date; and,

19 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds
20 may be placed automatically on consent agendas in committee, as they are usually
21 considered to be routine items, and this resolution authorizes the acceptance and expenditure
22 of grant funding; now, therefore, be it


23 RESOLVED, That SFDPH is hereby authorized to accept and expend retroactively a
24 grant in the amount of \$699,028 from SAMHSA; and, be it

1 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the
2 grant funds in accordance with the requirements set forth in the Agreement, pursuant to San
3 Francisco Administrative Code section 10.170-1; and, be it




4 FURTHER RESOLVED, That the Director of Health is authorized to enter into the

7 created under the grant as "G" or grant-funded positions which would terminate when the




