3 **Resolution enacting and rescinding parking regulations at various locations.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle  
6 Code and the San Francisco Traffic Code, the following regulations governing the  
7 parking of vehicles are hereby enacted or rescinded as designated below:

8 **TOW-AWAY, NO STOPPING ANYTIME - RESCIND**

9 Cesar Chavez Street, north side, between Illinois and Michigan Streets.

10 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

11 Donner Avenue, both west sides, from Phelps Street to easterly terminus  
(legislates existing parking conditions);

12 Donner Avenue, east side, from 50 feet south of Phelps Street to easterly  
13 terminus; and

14 Pacific Avenue, south side, between Lyon Street and Presidio Avenue (legislates  
existing parking conditions).

15 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

16 Hayes Street, north side, within the nine foot curb space between the driveways  
17 of 1448 and 1450 Hayes Street, west of Broderick Street.

18 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

19 1673 Page Street, between the driveways for 1669 and 1673 Page Street  
(11-foot space).

20  
21 Categorically exempt from Environmental  
22 Review Class 1(c)(9) changes in the traffic and  
23 parking regulations where such changes do not  
24 establish a higher speed limit or result in more  
than a negligible increase in the use of the  
street.




