3 **Resolution determining that the issuance of a Type 48 on-sale general public**  
4 **premises license to Robert Nunez, Steve Engelbrecht, and Craig Brition dba the**  
5 **Blind Tiger located at 1350 Powell Street (District 3), in exchange for its current**  
6 **Type 47 on-sale general eating place license, will serve the convenience of the**  
7 **people of the City and County of San Francisco, in accordance with Section**  
8 **23958.4 of the California Business and Professions Code, with conditions.**

10 WHEREAS, Robert Nunez, Steve Engelbrecht, and Craig Brition are seeking  
11 issuance of a Type 48 on-sale general public premises license for The Blind Tiger,  
12 located at 1350 Powell Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly  
14 zoned; and recommends approval;

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the issuance of a Type 48  
20 on-sale general public premises license, to Robert Nunez, Steve Engelbrecht, and Craig  
21 Brition for the Blind Tiger, located at 1350 Powell Street will serve the public  
22 convenience and necessity of the people of the City and County of San Francisco.

23 Conditions: (1) The sales and service of alcoholic beverages shall be permitted  
24 only between the hours of 11:00 a.m. and 2:00 a.m. each day of the week; (2) Petitioner  
25

1 shall regularly police the area under their control in an effort to prevent the loitering of  
2 persons about the premises; (3) The petitioner shall be responsible for maintaining free  
3 of litter the area adjacent to the premises over which they have control; (4)  
4 Entertainment provided shall not be audible beyond the area under control of the  
5 licensee.


