Resolution determining that the transfer of a Type 48 on-sale general public premises liquor license and Type 47 on-sale general eating place license to Lawrence P. Lin dba Loop Studio, Inc. from 2299 Van Ness Avenue to 55 Natoma Street (District 6) will serve the convenience of the people of the City and County of San Francisco, in accordance with Section 23958.4 of the California Business and Professions Code, with conditions.

10 WHEREAS, Lawrence P. Lin is seeking transfer of a Type 48 on-sale general
11 public premises liquor license and Type 47 on-sale general eating place license for
12 Loop Studio, Inc. located at 55 Natoma Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 **RESOLVED**, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 48
20 on-sale general public premises liquor license and Type 47 on-sale general eating place
21 license from 2299 Van Ness Avenue to 55 Natoma Street for Lawrence P. Lin for Loop
22 Studio, Inc., will serve the public convenience and necessity of the people of the City
23 and County of San Francisco.

24 Conditions: (1) Anytime the premises are providing entertainment or dancing,
25 licensee shall provide uniformed security guards inside and outside premises, including

1 the adjacent west parking lot, until one hour after closing and shall maintain order
2 therein; (2) Petitioner shall regularly police the area under their control in an effort to
3 prevent the loitering of persons about the premises; (3) The petitioner shall be
4 responsible for maintaining free of litter the area adjacent to the premises over which
5 they have control; (4) The sale of alcoholic beverages for consumption off the premises
6 is strictly prohibited; (5) Entertainment provided shall not be audible beyond the area
7 under control of the licensee.


