6 **serve the convenience of the people of the City and County of San Francisco, in**  
7 **accordance with Section 23958.4 of the California Business and Professions**  
8 **Code, with conditions.**

10 WHEREAS, Gilles W. Desaulniers is seeking issuance of a Type 20 off-sale beer  
11 and wine alcoholic beverage control license for CA Harvest Healthy Foods Ranch  
12 Market Inc., located at 199 Eighth Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly  
14 zoned and recommends approval; and

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 **RESOLVED, That in accordance with Section 23958.4 of the California Business**  
18 **and Professions Code, the Board of Supervisors of the City and County of San**  
19 **Francisco hereby determines for the foregoing reasons that the issuance of a Type 20**  
20 **off-sale beer and wine alcoholic beverage control license, to Gilles W. Desaulniers for**  
21 **CA Harvest Healthy Foods Ranch Market Inc., located at 199 Eighth Street will serve**  
22 **the public convenience and necessity of the people of the City and County of San**  
23 **Francisco.**

24 Conditions: (1) The sales and service of alcoholic beverages shall be permitted  
25 only between the hours of 8:00 a.m. and 12:30 a.m. each day of the week; (2) Petitioner

1 shall regularly police the area under their control in an effort to prevent the loitering of  
2 persons about the premises; (3) The petitioner shall be responsible for maintaining free  
3 of litter the area adjacent to the premises over which they have control; (4) No wine  
4 shall be sold with an alcoholic content of greater than 15% by volume except for "Dinner  
5 Wines" which have been aged two years or more and maintained in corked bottles; (6)  
6 The sale of beer and malt beverage products shall be restricted to import products and  
7 products produced by domestic microbreweries.




