9 WHEREAS, Brian T. Sheehy is seeking transfer of a Type 48 on-sale general
10 public premises license for Electrocelt Promotions Inc. dba "Swig", located at 561 Geary
11 Street; and,

12 WHEREAS, The City Planning Department has verified that the area is properly
13 zoned; and,

14 WHEREAS, The Police Department recommends that the liquor license
15 application be approved with conditions; now, therefore, be it

16 RESOLVED, That in accordance with Section 23958.4 of the California Business
17 and Professions Code, the Board of Supervisors of the City and County of San

18 Francisco hereby determines for the foregoing reasons that the transfer of a Type 48
19 on-sale general public premises license from 622 Polk Street to 561 Geary Street for
20 Brian T. Sheehy for Electrocelt Promotions Inc. dba "Swig", will serve the public
21 convenience and necessity of the people of the City and County of San Francisco.

22 Conditions: (1) The sales and service of alcoholic beverages shall be permitted
23 only between the hours of 10:00 a.m. and 2:00 a.m. each day of the week; (2) Petitioner
24 shall regularly police the area under their control in an effort to prevent the loitering of
25 persons about the premises; (3) The petitioner shall be responsible for maintaining free

1 of litter the area adjacent to the premises over which they have control; (4) The sale of
2 alcoholic beverages for consumption off the premises is strictly prohibited; (5) No noise
3 shall be audible beyond the area under control of the licensee.
