13 WHEREAS, The City Planning Department has verified that the area is properly  
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21  
20 off-sale general alcoholic beverage control license from 76 Geary Street to 360 Sutter  
21 Street (District 6) for Paul McGinlay for Hector Russell Scottish Imports dba The  
22 Whiskey Shop, will serve the public convenience and necessity of the people of the City  
23 and County of San Francisco.

24 Conditions: (1) The sales and service of alcoholic beverages shall be permitted  
25 only between the hours of 8:00 a.m. and 9:00 p.m. each day of the week; (2) Petitioner

1 shall regularly police the area under their control in an effort to prevent the loitering of  
2 persons about the premises; (3) The petitioner shall be responsible for maintaining free  
3 of litter the area adjacent to the premises over which they have control.




