3 **Resolution enacting and rescinding parking regulations at various locations.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle
6 Code and the San Francisco Traffic Code, the following regulations governing the
7 parking of vehicles are hereby enacted or rescinded as designated below:

8 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

9 Portola Drive, south side, from Diamond Heights Boulevard to 100 feet easterly.

10 **NO PARKING ANYTIME - ESTABLISH**

11 Waterville Street, east side, across from the north property line of 6 Waterville
12 Street, to the northern terminus of the roadway.

13 **TOW-AWAY, NO STOPPING ANYTIME - RESCIND**
TAXI ZONE - ESTABLISH

14 Polk Street, west side, between McAllister and Redwood Streets.

15 **TAXI STAND - RESCIND**

16 Dr. Carlton B. Goodlett Place, east side, from 208 feet to 232 feet south of
17 McAllister Street.

18 **RESIDENTIAL PERMIT PARKING AREA "S" (2-HOUR TIME LIMIT, 9 AM - 9 PM,
MONDAY THROUGH FRIDAY) - ESTABLISH**

19 Oak Street, both sides, between Gough and Octavia Streets (200 block)

20 179 Oak Street (adds specific address only, no permit parking signs will be
21 installed on the 100 block).

22 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

23 Baker Street, east side, between Turk Street and Golden Gate Avenue
(legislating existing conditions).

24 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

1 Noe Street, east side, from Elizabeth Street to 11 feet southerly (accommodates
two motorcycle parking spaces).

2 **RESIDENTIAL PERMIT PARKING AREA "U", 2-HOUR TIME LIMIT, 8 AM TO 10 PM,**
3 **MONDAY THROUGH SUNDAY - ESTABLISH**

4 Stillman Street, north side, from 3rd Street to 135 west of 3rd Street


5 101 and 147 Stillman Street, south side, between 3rd and 4th Streets (adds
specific addresses only); and

6 470 - 3rd Street, west side, between Bryant and Stillman Streets (adds specific
addresses only).

7 **PARKING METER NO. 3 (1-HOUR TIME LIMIT, 9 AM TO 6 PM, MONDAY THROUGH**
8 **SATURDAY)**

9 Stillman Street, north side, between 135 feet and 410 feet west of 3rd Street.

11 Categorically exempt from Environmental Review
12 Class 1(c)(9) changes in the traffic and parking
13 regulations where such changes do not establish a
higher speed limit or result in more than a negligible
14 increase in the use of the street.

Noe Street, east side, from Elizabeth Street to 11 feet southerly (accommodates two motorcycle parking spaces).

Stillman Street, north side, from 3rd Street to 135 west of 3rd Street

470 - 3rd Street, west side, between Bryant and Stillman Streets (adds specific addresses only).

Stillman Street, north side, between 135 feet and 410 feet west of 3rd Street.


