3 **Resolution authorizing the Department of the Environment to apply for annual grants**  
4 **from the California Integrated Waste Management Board for the purpose of increasing**  
5 **Used Motor Oil Recycling and Household Hazardous Waste Management.**

7 WHEREAS, the people of the State of California have enacted the California Oil  
8 Recycling Enhancement Act that provides funds to cities and counties for establishing and  
9 maintaining local used oil collection programs that encourage recycling or appropriate  
10 disposal of used oil; and,

11 WHEREAS, the California Integrated Waste Management Board has been delegated  
12 the responsibility for the administration of the program within the state, setting up necessary  
13 procedures governing application by cities and counties under the program; and,

14 WHEREAS, the grant is a non-competitive grant that is available to the City and County  
15 of San Francisco from the California Integrated Waste Management Board; and

16 WHEREAS, through a recurring grant cycle the City and County of San Francisco has  
17 annually entered into agreement with the State of California for implementation of used oil  
18 collection programs for the past nine (9) years; and,

19 WHEREAS, the grant is included in the annual budget process of the City and County  
20 of San Francisco and approved through the Annual Appropriation Ordinance; now, therefore,  
21 be it

22 RESOLVED, that the Director of the Department of the Environment, or a designee, is  
23 hereby authorized and empowered to execute in the name of the City and County of San  
24 Francisco all necessary applications, contracts, payment requests, agreements and




