14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21  
20 off-sale general alcoholic beverage control license from 555 Ninth Street, Suite 2 to the  
21 southeast corner of Bay and Mason Streets for Peter Impala, Agent for Trader Joe's  
22 Market, will serve the public convenience and necessity of the people of the City and  
23 County of San Francisco.

24 Conditions: (1) The petitioner(s) shall be responsible for maintaining free of litter  
25 the area adjacent to the premises over which they have control; (2) Sales and service of

1 alcoholic beverages shall be permitted only between the hours of 9:00 a.m. to 9:00 p.m.  
2 each day of the week; (3) Petitioner shall regularly police the area under their control in  
3 an effort to prevent the loitering of persons about the premises.


