1 [Opposing State Budget cuts to Child Care, Temporary Assistance to Need Families, and In
2 Home Support Services]

3 **Resolution urging the State Legislature to oppose Governor Schwarzenegger's**
4 **proposed budget cuts to Child Care, Temporary Assistance to Needy Families (TANF),**
5 **and In Home Support Services (IHSS), urging the San Francisco's state legislative**
6 **delegation to lead the way in finding additional resources; and urging Mayor Gavin**
7 **Newsom to mitigate impending cuts.**

9 WHEREAS, Governor Schwarzenegger's May Revision of the state budget proposes
10 significant cuts to child care, Temporary Assistance to Need Families, and In Home Support
11 Services; and,

12 WHEREAS, These proposed cuts will have a negative impact on vulnerable
13 communities of seniors, disabled adults and children, and economically disadvantaged adults
14 and children, and San Francisco will be disproportionately impacted by the state's reduced
15 participation, resulting in potential decreases and elimination of vital programs and services;
16 and,

17 WHEREAS, Quality, affordable child care and a trained, well-compensated child care
18 workforce allows children to learn and develop, enables working parents to stay on the job,
19 and supports the local economy; and,

21 WHEREAS, San Francisco has invested significant local dollars in its child care
22 infrastructure to support low-and moderate-income parents, ensure the highest quality care for
23 children, reward and retain dedicated teachers and providers, and stimulate partnerships with
24 the private sector; and,

1 WHEREAS, The proposed state budget cuts to child care will adversely affect
2 thousands children, parents, teachers, and providers, as well as dozens of the City's small,
3 medium and large employers; and,

4 WHEREAS, Governor Schwarzenegger's proposals to increase fees and co-payments
5 for low-income parents, cuts rates for providers, restrict subsidies for working families, and
6 eliminate care for at risk school age children will undermine years of local investments in the
7 City's child care system,

8 WHEREAS, San Francisco has utilized more than \$3 Million in Temporary Assistance
9 for Needy Families (TANF) funds to support innovative community-based services for at risk
10 youth and as alternatives to incarceration; and,

11 WHEREAS, The City and County of San Francisco has relied on a network of
12 community based organizations, juvenile justice experts, youth, and community advocates to
13 help lead a groundbreaking alternatives to detention initiative; and,

14 WHEREAS, These services include intensive case-management, jobs and skills
15 training, support services for families, counseling, and other kinds of intervention and
16 prevention services for youthful offenders and their families; and,

17 WHEREAS, Governor Schwarzenegger's proposed state budget and the May
18 Revision call for elimination of these critical funds to Juvenile Probation departments across
19 the state; and,

20 WHEREAS, More than 20 different community agencies providing services for up to
21 2000 youth each year could be completely dismantled, with untold consequences for the
22 youth and families affected, as well as the City's detention reform efforts; and,

1 WHEREAS, The Governor's May Revise calls for a reduction of state participation in
2 IHSS provider wages and benefits, eliminate domestic and related care for IHSS clients who
3 live with a family member, and eliminate state support for the IHSS Public Authority; and,

4 WHEREAS, IHSS program ultimately saves money by enabling seniors and disabled
5 adults to remain in their homes, as opposed to having to be institutionalized; now, therefore,
6 be it

7 RESOLVED, The Board of Supervisors strongly opposes the governor's child care
8 reform proposals and urges the San Francisco state legislative delegation to oppose child
9 care cuts in the state budget, and;

10 FURTHER RESOLVED, The Board of Supervisors urges the Mayor to specify
11 resources to mitigate state cuts to child care as one of the City's highest priorities; and be it

12 FURTHER RESOLVED, That the Board of Supervisors urges the Governor and
13 Legislature to preserve TANF allocations for Juvenile Probation Departments, and urge San
14 Francisco's state legislative delegation to lead the way in finding additional resources; and, be

17 FURTHER RESOLVED, That the Board of Supervisors urges the Mayor to make
18 restoration of these dollars to preserve community-based alternatives to detention, using local
19 monies if necessary, a high budget priority for FY 2004-2005; and, be it

20 FURTHER RESOLVED, That the Board of Supervisors urges the Governor and
21 Legislature to preserve IHSS funding, and urge the San Francisco's state legislative
22 delegation to lead the way in finding additional resources; ~~and, be it.~~


