10 create an environment for the residents of San Francisco that allows them to freely organize  
11 into trade unions; and,

12 WHEREAS, the City has encouraged, both by policy and example, its corporate  
13 citizens to negotiate union contracts in good faith, encouraging tolerance and diversity; and,

14 WHEREAS, the City is a financial stakeholder in the peaceful resolution of union and  
15 labor negotiations, with a strong interest in ensuring that its residents are safe, healthy, and  
16 productive; and,

17 WHEREAS, the Board of Supervisors of the City of San Francisco's mission is to  
18 respond to the needs of the people of this great City, encouraging actions that foster the  
19 safety, health, and economic vitality of the City and its residents; now therefore be it,

20 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
21 hereby goes on record as encouraging all parties in the upcoming September 2004 Grocery  
22 Store union contract negotiations to act in good faith to continue the safety, health, and  
23 economic vitality of both our corporate and union citizens and other residents of our City; and




