19 WHEREAS, The Recreation and Park Department has been a true partner to the Stern
20 Grove Festival Association throughout the years; and,

21 WHEREAS, The Stern Grove Festival Association has launched its legacy campaign
22 which is designed to (1) create a one-of-a-kind performing arts venue with state-of-the-art
23 features; (2) enhance and protect the natural beauty of Stern Grove; and, (3) endow the
