3 **Resolution authorizing the Director of Public Works to execute amendment to a design**
4 **agreement for the Laguna Honda Hospital Replacement Program from \$31,533,540 to**
5 **\$32,595,782.**

7 WHEREAS, The Director of Public Works has entered into an agreement dated
8 November 20, 2000 with Anshen+Allen/Gordon H. Chong & Partners, A Joint Venture for the
9 design of the Laguna Honda Hospital Replacement Program; and,

10 WHEREAS, Resolution 994-01, approved December 28, 2001, authorized the Director
11 to enter into amendments to the agreement which when amended would not exceed
12 \$29,900,000, and,

13 WHEREAS, Resolution 579-03, approved September 5, 2003, authorized the Director
14 to amend the November 20, 2000 agreement with Anshen+Allen/Gordon H. Chong, A Joint
15 Venture to an amount not to exceed \$31,533,540; and,

16 WHEREAS, the Director intends to increase the scope of services under said
17 agreement and to increase the sum under said agreement to \$32,595,782; and,

18 WHEREAS, Section 9.118(b) of the Charter requires that all agreements in excess of
19 ten million dollars or amendments to said agreements in excess of \$500,000 be approved by
20 the Board of Supervisors; now, therefore, be it

21 RESOLVED, That the Board of Supervisors does hereby authorize the Director of
22 Public Works to enter into amendments to the November 20, 2000 agreement with
23 Anshen+Allen/Gordon H. Chong, A Joint Venture, resulting in a contract amount not to
24 exceed \$32,595,782.
