3 **Resolution accepting the bequest of Doris Campos on behalf of needy senior residents**
4 **of San Francisco and designating the Department of Aging and Adult Services as the**
5 **department to manage the distribution of the estate.**

6 WHEREAS, Ms. Doris Campos bequeathed her property located at 2121 Golden Gate
7 Avenue to needy senior residents of San Francisco; and,

8 WHEREAS, Ms. Campos' will requests that her property be "used as a home, shelter
9 or meeting place for needy senior residents of San Francisco. If it is not economically feasible
10 to maintain this property for this purpose, then I direct that it be sold and that the proceeds of
11 the sale be applied for the general care, benefit and welfare of needy senior residents of San
12 Francisco;" and,

13 WHEREAS, Ms. Campos appointed Mr. Gary Lieberman, Esq., as the Executor of her
14 estate. Based upon the condition of the property, Mr. Lieberman obtained approval from the
15 probate court to proceed with the sale of the property; and,

16 WHEREAS, Ms. Campos' intent can best be served if the Department of Aging and
17 Adult Services assumes responsibility under the oversight of the Board of Supervisors for the
18 distribution of the estate consistent with the terms of the will and subject to final approval by
19 the probate court; now, therefore, be it

20 RESOLVED, That the City and County of San Francisco accepts the bequest of Doris
21 Campos on behalf of needy senior residents of San Francisco; and, be it

22 FURTHER RESOLVED, That the Executor is authorized to seek approval from the
23 probate court for the designation of the Department of Aging and Adult Services as the City
24 department that will be responsible for managing the expenditures from the estate consistent

5 estate consistent with the terms of the will prior to making distributions to needy senior
6 residents of San Francisco: and, be it

7 FURTHER RESOLVED, That the Department of Aging and Adult Services in
8 consultation with the Homeless Senior Task Force, shall recommend an expenditure plan that
9 address the needs of the senior homeless population including the Senior Homeless Assertive
10 Case Management Program.


