9 WHEREAS, The California State Library's Public Library Staff Education Program is
10 dedicated to providing tuition reimbursement for library staff pursuing a degree or certification
11 in Library Science; and,

12 WHEREAS, Four non-professional employees of the Public Library applied to the
13 California State Library to participate and receive specific tuition reimbursement amounts and
14 four were accepted into the program; and,

15 WHEREAS, The California State Library has awarded \$4,257 to the Public Library to
16 reimburse the students/employees for Summer 2004 tuition fees; and,

17 WHEREAS, Students/employees will provide official transcripts and registration fee
18 receipts as evidence of completing said classes prior to receiving reimbursement; and,

19 WHEREAS, The Public Library has a goal of promoting equal access to professional
20 development opportunities for all employees; and,

21 WHEREAS, The grant budget includes provision for indirect costs of \$387; now,
22 therefore, be it


23 RESOLVED, That the Public Library be authorized to accept and expend \$4,257

25 participating employees.


