4 **applications to the California State Library Department in order to provide for funding**  
5 **for Sunnyside Conservatory Renovation, Harvey Milk Performing Arts Center, 24<sup>th</sup> and**

8 WHEREAS, The people the State of California have enacted the California Clean  
9 Water, Clean Air, Safe Neighborhood Parks, and Coastal Protection Act of 2002 which  
10 provides funds to the State of California for the California Cultural and Historical Endowment  
11 (CCHE) Grant Program; and,

12 WHEREAS, The CCHE has determined that, of the \$122 million in Proposition 40  
13 funds available for the CCHE competitive grant program, up to \$35 million will be made  
14 available for the first round of funding; and,

15 WHEREAS, The Recreation and Park Department has decided to apply for matching  
16 grants for Sunnyside Conservatory Renovation in the amount of \$785,431, Harvey Milk  
17 Performing Arts Center in the amount of \$1,000,000 and 24<sup>th</sup> Street/York Mini Park in the  
18 amount of \$144,918; and

19 WHEREAS, The these projects fall within the guidelines of CCHE's charge to  
20 provide grants for the restoration, preservation and interpretation of California's historical and  
21 cultural resources; now, therefore, be it

22 RESOLVED, That the Board of Supervisors hereby supports the California Cultural  
23 and Historical Endowment grant applications by the Recreation and Park Department for the  
24 Sunnyside Consevatory Renovation, Harvey Milk Performing Arts Center, 24<sup>th</sup> Street and York  
25 Mini Park; and be it




