

1 [Approval of the MOU between the San Francisco Police Department and the San Francisco
2 Housing Authority for additional police services.]

3 **Resolution retroactively approving the Memorandum of Understanding between the**
4 **San Francisco Police Department and the San Francisco Housing Authority for**
5 **additional police services in designated Housing Authority Developments.**

7 WHEREAS, Various Housing Authority Developments are entirely within the
8 boundaries of the City and County of San Francisco and are located on streets owned by the
9 City and County of San Francisco; and

10 WHEREAS, The San Francisco Police Department is required to furnish or cause to be
11 furnished to the tenants of such public housing developments police services of the same
12 character and extent as are furnished, without a service fee, to other dwellings and inhabitants
13 in the City and County of San Francisco; and,

14 WHEREAS, The San Francisco Police Department provides public law enforcement
15 services in the City and County of San Francisco, which includes Housing Authority
16 Developments; and,

17 WHEREAS, The Housing Authority has experienced various levels of crime, including
18 drug and gang problems, at its Authority Housing Developments; and

19 WHEREAS, It is the common goal of the San Francisco Police Department and the
20 Housing Authority to provide a supplemental law enforcement program to reduce crime and
21 fear of crime in the Housing Authority Developments; and

22 WHEREAS, For the purpose of achieving such common goal, the Housing Authority
23 has requested the San Francisco Police Department to provide supplemental law
24 enforcement community policing services to certain of its Authority-owned, and annually

1 identified Housing Developments, over and above the law enforcement services provided to
2 the public generally, for the period of two years starting July 1, 2004 and ending on June 30,
3 2006; and

4 WHEREAS, The San Francisco Police Department is willing to make available, for a
5 fee of one million dollars (\$1,000,000) a year, trained San Francisco Police Department
6 personnel to provide supplemental law enforcement community policing services dedicated to
7 designated Housing Authority Developments; now, therefore, be it

8 RESOLVED, That Board hereby retroactively approves the Memorandum of
9 Understanding between the San Francisco Police Department and the San Francisco Police
10 Department for supplemental law enforcement for the period of two years, starting July 1,
11 2004 and ending June 30, 2006, for the fee of one million dollars (\$1,000,000) a year.
