4 **alcoholic beverage control license from 2055 McAllister to the Northeast corner of**
5 **Broderick and Oak Streets (District 5) to James L. Falletti for Falletti & Baldocchi**
6 **Finer Foods, Inc., dba Falletti Foods, will serve the public convenience and**
7 **necessity of the people of the City and County of San Francisco, in accordance**
8 **with Section 23958.4 of the California Business and Professions Code, with**
9 **conditions.**

11 WHEREAS, James L. Falletti is seeking transfer of a Type 20 off-sale beer and
12 wine alcoholic beverage control license for Falletti & Baldocchi Finer Foods, Inc., dba
13 Falletti Foods, located at the Northeast corner of Broderick and Oak Streets; and,

14 WHEREAS, The City Planning Department has verified that the area is properly
15 zoned; and,

16 WHEREAS, The Police Department recommends that the liquor license
17 application be approved with conditions; now, therefore, be it

18 **RESOLVED**, That in accordance with Section 23958.4 of the California Business
19 and Professions Code, the Board of Supervisors of the City and County of San
20 Francisco hereby determines for the foregoing reasons that the transfer of a Type 20
21 off-sale beer and wine alcoholic beverage control license from 2055 McAllister Street to
22 the Northeast corner of Broderick and Oak Streets (District 5) for James L. Falletti for
23 Falletti & Baldocchi Finer Foods, Inc., dba Falletti Foods, will serve the public
24 convenience and necessity of the people of the City and County of San Francisco.

1 Conditions: (1) The petitioner(s) shall be responsible for maintaining free of litter
2 the area adjacent to the premises over which they have control; (2) Sales and service of
3 alcoholic beverages shall be permitted only between the hours of 7:00 a.m. to 11:00
4 p.m. each day of the week; (3) Petitioner shall regularly police the area under their
5 control in an effort to prevent the loitering of persons about the premises; (4) Not more
6 than 2000 square feet of the premises will be used for the display of alcoholic
7 beverages; (5) Display windows shall not be covered and no more than 25 percent of
8 the retail storefront will be covered with advertisements. No refrigeration appliances or
9 other large objects shall block the display windows.




