4 **newspaper of the City and County of San Francisco for the category of Type 2 non-**
5 **consecutive day official advertising, for the period commencing July 1, 2004 and**
6 **ending June 30, 2005.**

8 WHEREAS, in each year, the Board of Supervisors shall designate the official
9 newspaper of the City and County of San Francisco, pursuant to Article IX, Section 2.80-1 and
10 2.81 of the San Francisco Administrative Code; now therefore, be it

11 RESOLVED, that the San Francisco Independent Chronicle, a newspaper of general
12 circulation published in the City and County of San Francisco for the dissemination of local or
13 telegraphic news and intelligence of a general character, having a bona fide circulation of at
14 least 50,000 copies per calendar week, printed in the City and County on three or more days
15 in a calendar week, is hereby designated as an official newspaper of the City and County of
16 San Francisco, commencing July 1, 2004 for the publication of all official advertising of the
17 City and County which is required by law, other than the provisions of Section 2.103 of the
18 Charter as they relate to special meetings of the Board of Supervisors and its special or
19 standing committees, to be published one time, and all official advertising of the City and
20 County which is required by law to be published more than one, but not more than three times
21 per week for a specified number of weeks, and, be it

22 FURTHER RESOLVED, that the Office of Contract Administration is hereby authorized
23 to execute a contract with the San Francisco Independent Chronicle and said contract must
24 be in accordance with all the contracting requirements of the City and County of San
25 Francisco.


