1 [Creating a Community Choice Aggregation Citizens Advisory Task Force]

2  
3 **Resolution creating a Citizens Advisory Task Force to advise the City and County of**  
4 **San Francisco regarding the design and implementation of a Community Choice**  
5 **Aggregation Program in accordance with ordinance 86-04.**

7 WHEREAS, The Board of Supervisors unanimously passed, and the Mayor signed  
8 Ordinance 86-04 establishing a Community Choice Aggregation (CCA) Program, allowing San  
9 Francisco to aggregate the electrical load of electrical consumers in San Francisco pursuant  
10 to Assembly Bill 117; and,

11 WHEREAS, Ordinance 86-04 established a mechanism for San Francisco to  
12 accelerate the introduction of renewable energy, conservation and energy efficiency into San  
13 Francisco's portfolio of energy resources; and,

14 WHEREAS, the City has a mandate to facilitate the rapid and large-scale development  
15 of renewable energy and conservation resources; and,

16 ~~WHEREAS, in December 2002, San Francisco adopted an Electricity Resource Plan~~  
17 ~~calling for the development of 107 Megawatts of load reduction through electricity load~~  
18 ~~management and efficiency measures, 31 Megawatts of in-City solar energy, 72 Megawatts of~~  
19 ~~small-scale distributed generation such as fuel cells in San Francisco and 150 Megawatts of~~  
20 ~~new wind energy capacity by 2012; and,~~

21 WHEREAS, Ordinance 86-04 called for the development of 107 Megawatts of load  
22 reduction through electricity load management and efficiency measures, 31 Megawatts of in-  
23 City solar energy, 72 Megawatts of small-scale distributed generation such as fuel cells in San  
24 Francisco and 150 Megawatts of new wind energy capacity by 2012, as called for by the  
25 Electricity Resource Plan adopted by San Francisco in December 2002; and

1           WHEREAS, Ordinance 86-04 directed City departments to work with City finance staff  
2 to determine how Proposition H Bonds may be used to augment CCA by providing financing  
3 for renewable energy and conservation projects, including a bond-repayment schedule based  
4 on anticipated revenues collected from monthly electric bills and other sources; and,

5           WHEREAS, San Francisco residents have expressed concern that air pollution from  
6 fossil fuel power generation in the City is a contributing factor in the cause of asthma and  
7 other diseases; and,

8           WHEREAS, Ordinance 86-04 required the San Francisco Public Utilities Commission  
9 (SFPUC) and the San Francisco Department of the Environment (DOE) (collectively,  
10 "Departments") to develop a CCA Draft Implementation Plan and Request for Proposals for  
11 consideration by the Board of Supervisors; now, therefore, be it

12           RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
13 hereby establishes a Community Choice Aggregation Citizens Advisory Task Force consisting  
14 of seven members who will represent the following officials and groups: The Board of  
15 Supervisors shall appoint by majority vote (1) one expert on Community Choice Aggregation  
16 and (2) one expert in municipal revenue bond financing; (3) one environmental justice  
17 advocate currently residing in Hunters Point, and (4) one representative of labor. The Mayor  
18 shall appoint (5) one representative of the business community and (6) one technical expert in  
19 energy efficiency from the Department of the Environment; and the General Manager of the  
20 SFPUC shall appoint (7) one representative with technical expertise in energy resources  
21 planning at the SFPUC; and, be it

22           FURTHER RESOLVED, That the Task Force members shall choose one member from  
23 among themselves to serve as chair of the Task Force; and, be it

1 FURTHER RESOLVED, That the Task Force shall advise the City on 1) the goals and  
2 preparation of a CCA Implementation Plan, 2) the use of Proposition H Bonds to accelerate  
3 the use of renewable energy, conservation and energy efficiency in the CCA program, and 3)  
4 the requirements in the CCA bid solicitation process, and 4) the evaluation of bids; and, be it

5 FURTHER RESOLVED, That the ~~Board of Supervisors requests the Clerk of the Board~~  
6 Public Utilities Commission is to provide administrative support for the Task Force; and, be it

7 FURTHER RESOLVED, That the appointment of members to the Task Force shall  
8 automatically expire on May 31, 2006.


