**Resolution authorizing the Department of the District Attorney of the City and County of San Francisco to retroactively accept and expend a grant in the amount of \$110,000 through the California Governor’s Office of Emergency Services, Criminal Justice Programs Division, for the operation of a program entitled “Special Emphasis Victim Assistance Program: Elder Abuse.”**

WHEREAS, The City and County of San Francisco desires to continue a certain project designated the San Francisco Special Emphasis Victim Assistance Program : Elder Abuse, to be funded in part from funds made available through the Governor’s Office of Emergency Services, Criminal Justice Programs Division (CJPD); and,

WHEREAS, CJPD requires that the City and County of San Francisco, through the Office of the District Attorney, provide no less than a twenty percent in-kind match for the grant; and

WHEREAS, All positions supported by these funds shall be coded “G” in the District Attorney’s budget; and,

WHEREAS, The terms of the grant prohibit inclusion of indirect costs in the grant budget; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of the City and County of San Francisco to retroactively accept and expend funds from CJPD for the purposes of special emphasis victim assistance program: elder abuse; and, be it

FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget; and be it


1 FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of

5 FURTHER RESOLVED, That the District Attorney is authorized and empowered to  
6 execute, deliver and perform, in the name of the City and County of San Francisco, all  
7 applications, contracts, agreements, amendments and payment requests necessary for the  
8 purpose of securing Special Emphasis Victim Assistance Program: Elder Abuse grant funds  
9 and to implement and carry out the purposes specified in the applicable grant application; and  
10 be it

11 FURTHER RESOLVED, That any liability arising out of the performance of the Grant  
12 Award Agreement, including civil court actions for damages, shall be the responsibility of the  
13 grant recipient and the authorizing agency; and be it

14 FURTHER RESOLVED, That grant funds received hereunder shall not be used to  
15 supplant expenditures controlled by this body.




