

1 [Appointment - Veterans Affairs Commission]

3 **Resolution appointing Jill Buck, term ending January 31, 2006, to the Veterans Affairs**  
4 **Commission; residency requirement waived.**

5  
6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
7 does hereby appoint the hereinafter designated person to serve as a member of the Veterans  
8 Affairs Commission, pursuant to the provisions of the San Francisco Administrative Code,  
9 Section 5.102, for the term specified:

10 Jill Buck (residency requirement waived), succeeding Carla Hollis, resigned, seat 5,  
11 must be a woman veteran, for the unexpired portion of a four-year term ending January 31,  
12 2006; and, be it

13 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 14 1. The membership of the Veterans Affairs Commission has a goal to be  
15 representative of the diversity of the City and County of San Francisco.
- 16 2. Applicant Jill Buck, a new appointee, who is not a resident of San Francisco, is a  
17 person with experience that uniquely qualifies him/her to serve on the Veterans  
18 Affairs Commission.
- 19 3. The Veterans Affairs Commission has attempted to fill the position, for which Jill  
20 Buck was nominated, with an individual who is a City resident and who has the  
21 specific experience, skills, and qualifications, but has been unable to do so at this  
22 time. The Rules Committee has certified that Jill Buck is qualified to serve on the  
23 Veterans Affairs Commission.
- 24 4. After exercising due diligence, the Board of Supervisors concludes that there is no  
25 other possible representative, who is a resident of San Francisco and who has the

1 specific experience, skills, or qualifications possessed by this applicant, and who is  
2 willing to serve on the Veterans Affairs Commission at this time; and, be it

3 FURTHER RESOLVED, That the Board of Supervisors waives the residency  
4 requirement for Jill Buck, as allowed in cases where no qualified City resident, willing to serve,  
5 can be found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed  
6 to boards, commissions, and advisory bodies established by legislative act of the Board of  
7 Supervisors to be resident(s) of the City and County of San Francisco.
