14 WHEREAS, the San Francisco Foundation is a leading agent of Bay Area philanthropy,  
15 seeking to inform and engage residents in the civic life of our community while providing  
16 access to the diverse arts and cultural life of the Bay Area; and,

17 WHEREAS, the San Francisco Foundation supports the Department of Public Works  
18 efforts to provide additional commemorative elements in United Nations Plaza to promote the  
19 understanding of the vital role of the United Nations; and,

20 WHEREAS, the Department of Public Works is responsible for implementing capital  
21 improvements to the United Nations Plaza; and,

22 WHEREAS, the subject gift of \$115,000 from the San Francisco Foundation would  
23 provide for the installation of commemorative elements in the United Nations Plaza; now,




