7 and helped organize employees who voted to join the Building Service Employees, Local 6  
8 which is now the Service Employees International Union; and

10 WHEREAS, Bill Price joined the United States Navy in 1945 after his discharge moved

12 to San Francisco to work in his father's grocery store; and  
13 WHEREAS, Bill Price joined the Retail Clerks Local 648 in 1947 and was an active  
14 member and was elected to the Executive Local Board by the early 1960s where he served as  
15 Vice President and then as an Organizer and finally as business agent until his retirement;

18 WHEREAS, Bill Price has, since his retirement been busier than ever working to  
19 improve conditions for seniors, workers and their families; and

21 WHEREAS, Bill Price currently serves as President of the Senior Action Network and a  
22 Vice President of the California Alliance for Retired Americans representing UFCW Retirees  
23 along with a host of other organizational affiliations too numerous to mention; and

25 WHEREAS, Bill Price is a season ticket holder to both the San Francisco 49ers and the  
San Francisco Giants, where he can always be found when he is not on a picket line; now,  
therefore, be it

RESOLVED, That the San Francisco Board of Supervisors wishes Bill Price a happy

90<sup>th</sup> birthday and hereby declares February 24<sup>th</sup> 2005 as Bill Price Day in San Francisco.


