11 WHEREAS, Many people with disabilities are misguided by the idea that having a job  
12 means potentially losing crucial health and/or other needed benefits; and,

13 WHEREAS, The San Francisco Independent Living Resource Center and the SF  
14 Planning Committee have partnered to provide the “Cross Agency Training On Health,  
15 Benefits, Work and Disability; and,

16 WHEREAS, This training goal is to achieve an awareness level that youth and adult  
17 job seekers and workers with disabilities can access needed information about their benefits  
18 and protection when working; and,

19 WHEREAS, The Cross agency training is an up-front personal way to share  
20 knowledge while building local network of staff who share their knowledge more effectively  
21 after the training; now, therefore, be it

22 **RESOLVED, That the San Francisco Board of Supervisors commend the San**  
23 **Francisco Independent Living Resource Center and their partners of the San Francisco Cross**  
24 **Agency Training program for their efforts to provide workers and job seekers with disabilities**  
25 **accurate information and access to their rights at the workplace.**


