4 **Resolution authorizing the Mayor of the City and County of San Francisco to retroactively accept**
5 **and expend grants from the U.S. Department of Housing and Urban Development (HUD) for a**
6 **total amount of \$1,358,286 including \$858,286 for the HOME American Dream Downpayment**
7 **Initiative Program, and \$500,000 in Competitively Reallocated HOME Funds to Provide**
8 **Permanent Housing for the Chronically Homeless, authorized under TITLE II of the National**
9 **Affordable Housing Act of 1990, Public Law Number 101-625**

10 WHEREAS, The City and County of San Francisco (The City) is an eligible city for purposes of
11 receiving funds from the HOME Investment Partnership (HOME) Program and has received a formula
12 allocation of Eight Hundred Fifty Eight Thousand Two Hundred Eighty Six Dollars (\$858,286) under a
13 new downpayment assistance component of the HOME Program, referred to as the American Dream
14 Downpayment Initiative (ADDI); and

15 WHEREAS, The City has also received a special purpose grant of \$500,000 in HOME funds
16 pursuant to an application prepared by the Mayor's Office of Housing in response to a Notice of Funding
17 Availability issued by HUD for the Competitive Reallocation of HOME Funds for Permanent Housing
18 for the Chronically Homeless; and

19 WHEREAS, The ADDI will be used to assist low income families achieve homeownership, and
20 the HOME Funds for Permanent Housing for the Chronically Homeless will be used for the
21 development, acquisition and rehabilitation of permanent, supportive housing for chronically homeless
22 persons in accordance with the City's 2004-2005 Consolidated Plan Action Plan and in furtherance of the
23 Residence Element of the General Plan; and

24 WHEREAS, The City's 2004-2005 Consolidated Plan Action Plan was adopted by the Board of


1 Supervisors pursuant to Resolution No. 287-04 and submitted to HUD on May 11, 2004, and is on file
2 with the Clerk of the Board of Supervisors and incorporated herein by reference; and

3 WHEREAS, The administrative and direct costs of administering the ADDI and HOME Funds
4 for Permanent Housing for the Chronically Homeless Programs are eligible Community Development
5 Block Grant (CDBG) expenses, and will be paid from CDBG funds through the 2004 Community
6 Development Program; now, therefore, be it


7 RESOLVED, That the Mayor of the City and County of San Francisco is authorized to
8 retroactively accept and expend the ADDI funds and the HOME Funds for Permanent Housing for the
9 Chronically Homeless from HUD according to the Federal rules and Regulations for the program and
10 the 2004-2005 Consolidated Plan Action Plan; and, be it


11 FURTHER RESOLVED, That the Mayor is hereby authorized to submit documentation and


