7 WHEREAS, The structure known as St. Brigid's, located at the intersection of Van
8 Ness and Broadway Streets in San Francisco, was built in 1900 and boasts notable historic
9 features; and,

10 WHEREAS, The structure, designed by Henry Minton, survived both the 1906 and
11 1989 earthquakes before the Catholic Archdiocese of San Francisco chose to discontinue its
12 operation as a place of worship in 1994; and,

13 WHEREAS, The Executive Director of San Francisco Architectural Heritage recently
14 described the importance of preserving this historic structure by noting, "[t]he design and
15 craftsmanship are something we'll never be able to afford again"; and,

16 WHEREAS, On February 9th, 2005, California State Senator Carole Migden introduced
17 SB 169, on file with the Clerk of the Board of Supervisors in File No. , which is hereby
18 declared to be a part of this resolution as if set forth fully herein; and,

19 WHEREAS, SB 169 is aimed at establishing state policy regarding the importance of
20 preserving the historic structure known as St. Brigid Church; now, therefore, be it

21 **RESOLVED**, That the Board of Supervisors of the City and County of San Francisco
22 hereby expresses its support for Senate Bill 169, introduced by Senator Carole Migden; and,

2 will lead to the preservation and possible adaptive reuse of the historic structure known as St.

6 FURTHER RESOLVED, That upon final adoption of this resolution, the Clerk of the
7 Board of Supervisors shall transmit copies of this resolution to members of the California
8 State Assembly and Senate who represent San Francisco.
