17 and public access; open-meeting laws; recreational and athletic opportunities and programs;  
18 representative of public safety officers on Treasure Island; representative of TIHDI;  
19 representative of Job Corps; representative of Treasure Island Elementary School;  
20 representative of film production industry; and representative of residential tenants on  
21 Treasure Island, for the unexpired portion of a four-year term ending December 31, 2008.

22 Natalie Bonnewit, succeeding Marnella Goncalves, resigned, seat 10, must possess  
23 any of the following qualifications: Any of the following: land use and urban planning and  
24 architecture; transportation planning and alternative and mass transit; historic conservation  
25 and preservation; engineering and construction; real estate development and financing;

1 economic development and job generation and organized labor; first-source hiring, welfare-to-  
2 work and other job broker programs; affordable and low-income housing; marine related  
3 activities; natural resource preservation and conservation; environmental and toxic  
4 remediation and control; tideland trust and public access; open-meeting laws; recreational and  
5 athletic opportunities and programs; representative of public safety officers on Treasure
