10 France, to be held on July 24, 2005; and,

11 WHEREAS, Armstrong announced he plans to spend more time with his family and
12 speaking out on behalf of cancer research; and,

13 WHEREAS, This announcement means that San Franciscans and visitors will no
14 longer be able to see Mr. Armstrong participate in or win the San Francisco Grand Prix, a
15 City-subsidized bicycle race sponsored by San Francisco Cycling, LLC, a Delaware
16 corporation, and held here in San Francisco; now, therefore, be it

17 RESOLVED, That the San Francisco Board of Supervisors commends Lance
18 Armstrong on his stellar career and wishes him well in his final Tour de France; and, be it

19 FURTHER RESOLVED, That the Board of Supervisors declares July 24, 2005 as
20 "Lance Armstrong Day" in the City and County of San Francisco; and, be it

21 FURTHER RESOLVED, That the Board of Supervisors extends its best wishes to
22 Lance Armstrong on the occasion of his retirement: and, be it,

23 FURTHER RESOLVED, That the Board directs the Clerk of the Board to forward a
24 copy of this enacted resolution to Lance Armstrong and San Francisco Cycling, LLC.


