11 WHEREAS, Increasing walking traffic in neighborhood commercial districts tends to  
12 enhance the overall economic vitality of the district; and,

13 WHEREAS, ISCOTT approval of the temporary sidewalk occupancy will be filed with  
14 the Clerk of the Board of Supervisors in File No. , which is hereby declared to be a part of  
15 this resolution as set forth fully herein; and,

16 WHEREAS, The Board of Supervisors is the appropriate policy body to approve an  
17 extended temporary occupancy permit; now, therefore, be it

18 RESOLVED, That, in accordance with the provisions of the California Vehicle Code  
19 and the San Francisco Traffic Code, the following regulation governing the movement of  
20 vehicles is hereby enacted as designated below

21 Temporary Sidewalk occupancy, 8:00 A.M. to 3:00 P.M., Every Saturday Between May  
22 28, 2005 through October 29, 2005, on Fillmore Street between Bay and Chestnut Streets for  
23 a Farmers Market.


