10 bodies by providing the only meals that our students will receive, but serve as the bridge  
11 between the parents and the school and are often the parents and grandparents of our  
12 students; and

13 WHEREAS, Classified employees further serve as translators, work with severely  
14 mentally and physically disabled students, provide clean classrooms and facilities, record and  
15 preserve their pertinent school records, maintain the libraries and provide an environment that  
16 is conducive to learning in San Francisco's public schools; and

17 WHEREAS, Classified employees have, over the last few years have, experienced  
18 increasing budget cuts resulting in reduced staffing and school closures; and

19 WHEREAS, Classified employees have had a larger share of the health care costs  
20 passed onto them, their retirement benefits attacked by the governor, and are threatened with  
21 losing their seniority rights under civil service reform proposals, and

22 WHEREAS, These valuable workers are not only the first workers to be laid off or  
23 displaced as school state monies erode, but they have not received a raise in the last three  
24 years; and

1           WHEREAS, the labor of these classified employees is critical to the overall effort to  
2 successfully educate San Francisco's school children and the next generation and these  
3 employees continue to provide an excellent service to the community under very difficult  
4 circumstances; now, therefore be it

5           RESOLVED, That the Board of Supervisors of San Francisco hereby support the  
6 negotiations in good faith between Service Employees International Union (SEIU) and United  
7 Educators of San Francisco (UESF) to ensure that classified employees are adequately  
8 honored and appreciated for the invaluable service they provide to the children of San  
9 Francisco; and be it

10           FURTHER RESOLVED, that the Board of Supervisors hereby honor and recognize


