9 WHEREAS, Peter W. Langenstein is seeking issuance of a Type 20 off-sale beer
10 and wine license for Peloton Services, Inc., located at 740 Clementina Street; and,

11 WHEREAS, The City Planning Department has verified that the area is properly
12 zoned; and

13 WHEREAS, The Police Department recommends that the liquor license
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business
16 and Professions Code, the Board of Supervisors of the City and County of San
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 20
18 off-sale beer and wine license, to Peter W. Langenstein for Peloton Services, Inc.,
19 located at 740 Clementina Street will serve the public convenience and necessity of the
20 people of the City and County of San Francisco.

21 Conditions: (1) The off-sale beer and wine license shall be held only in
22 conjunction with, and at the same location as, a beer and wine wholesale license; (2)
23 The off-sale beer and wine license shall be restricted to sales solicited and accepted by
24 direct mail, telephone, or on-line computer. The off-sale beer and wine license shall not
25 be used for operations conducted from a retail store open to the public.
