3 **Resolution appointing William Hamilton, term ending April 30, 2007 to the Animal**
4 **Control and Welfare Commission. (Residency requirement waived)**
5

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 does hereby appoint the hereinafter designated person to serve as a member of the Animal
8 Control and Welfare Commission, pursuant to the provisions of the San Francisco Health
9 Code, Section 41.1, for the term specified:

10 William Hamilton (residency requirement waived), succeeding Chin Chi, term expired,
11 Seat No. 4, must be a member representing the general public having interest and experience
12 in animal matters, for the unexpired portion of a 2-year term ending April 30, 2007.

13 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 14 1. The membership of the Animal Control and Welfare Commission has a goal to be
15 representative of the diversity of the City and County of San Francisco.
- 16 2. Applicant William Hamilton, a new appointee, who is not a resident of San
17 Francisco, is a person with experience that uniquely qualifies him/her to serve on
18 the Animal Control and Welfare Commission.
- 19 3. The Animal Control and Welfare Commission has attempted to fill the position, for
20 which William Hamilton was nominated, with an individual who is a City resident
21 and who has the specific experience, skills, and qualifications, but has been unable
22 to do so at this time. The Rules Committee has certified that William Hamilton is
23 qualified to serve on the Animal Control and Welfare Commission.
- 24 4. After exercising due diligence, the Board of Supervisors concludes that there is no
25 other possible representative, who is a resident of San Francisco and who has the

1 specific experience, skills, or qualifications possessed by this applicant, and who is
2 willing to serve on the Animal Control and Welfare Commission at this time; and, be
3 it

4 FURTHER RESOLVED, That the Board of Supervisors waives the residency
5 requirement for William Hamilton, as allowed in cases where no qualified City resident, willing
6 to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)
7 appointed to boards, commissions, and advisory bodies established by legislative act of the
8 Board of Supervisors to be resident(s) of the City and County of San Francisco.




