7 WHEREAS, Section 3.581 of the Charter of the City and County of San Francisco  
8 empowers the Port Commission to use, conduct, operate, maintain, manage, regulate and  
9 control Port area of the City and County of San Francisco; and,

10 WHEREAS, The Port of San Francisco is home to the Bay Area's harbor service  
11 industry; and

12 WHEREAS, It is in the Port's and the public's interest to promote maritime activities at  
13 the Port of San Francisco; and,

14 WHEREAS, The San Francisco Bar Pilots are responsible for the safe passage of  
15 more than 8500 vessels every year through the San Francisco, Monterey, San Pablo and  
16 Suisun Bays; and,

17 WHEREAS, If adopted by the Legislature and signed by the Governor, AB 852 would  
18 allow funds collected by the San Francisco Bar Pilots for new pilot vessel acquisition to also  
19 be used for design and engineering modification to extend the service life of existing pilot  
20 vessels; and,

21 WHEREAS, The extension of vessel service lives by modernization is a proven and  
22 cost effective practice based on common U.S. Navy, U.S. Coast Guard and merchant marine  
23 industry experience; now, therefore, be it
