4 **Francisco Unified School District Superintendent and School Board not to close the**  
5 **Center.**

7 WHEREAS, The Presidio Child Development Center (CDC) has been operating in the  
8 Presidio since 1995; and

9 WHEREAS, Hundreds of children from all over the City, including over 22 different  
10 neighborhoods attend the Center; and,

11 WHEREAS, The Presidio CDC is 100% enrolled with a 300 plus wait list; and

12 WHEREAS, The Presidio CDC has a diverse socio-economic and ethnic student  
13 population with 70% of the students coming from low income families and 62% coming from  
14 families that speak English as a second language; and

15 WHEREAS, The Presidio CDC provides the only inclusion special needs program in  
16 the San Francisco public schools as well as the only infant and toddler program; and

17 WHEREAS, The Presidio CDC provides infant toddler care, which represents one of  
18 the highest unmet care needs in the City with only 1 licensed infant toddler care slot available  
19 for every 24 children in need; and

20 WHEREAS, The Presidio CDC has the only program in the city to offer a continuum of  
21 care from infant age through 5<sup>th</sup> grade; now, therefore, be it

22 RESOLVED, That the San Francisco Board of Supervisors urges the San Francisco  
23 Unified School District Superintendent and Board of Education to not close the Presidio Child  
24 Development Center; and, be it




