Resolution authorizing the Mayor’s Office of Criminal Justice to retroactively accept and expend a grant in the amount of \$116,941 from the State Board of Corrections for the purpose of implementing local juvenile justice accountability measures through the Juvenile Accountability Block Grant (JABG).

WHEREAS, the Mayor’s Office of Criminal Justice (MOCJ) desires to undertake a certain project, designated Juvenile Accountability Block Grant, to be funded in part from funds made available through the JABG Program administered by the Board of Corrections (BOC), now, therefore, be it

RESOLVED, that the Director of MOCJ is authorized, on its behalf to submit the attached proposal to BOC and is authorized to sign and approve on behalf of the City and County of San Francisco the attached Grant Award Agreement including any extensions or amendments thereof; and

BE IT FURTHER RESOLVED that the applicant agrees to provide all matching funds required for said project (including any amendment thereof) under the Program and the funding terms and conditions of BOC and that the match will be appropriate as required.

IT IS AGREED that any liability arising out of the performance of this Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and BOC disclaim responsibility for any such liability.

BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
