3 **Resolution determining that the transfer of a Type 21 off-sale general alcoholic**  
4 **beverage control license to Zain Azzghayer for business located at 238 Sansome**  
5 **Street, Suite 110 from 333 O'Farrell Street will serve the public convenience and**  
6 **necessity of the people of the City and County of San Francisco, in accordance**  
7 **with Section 23958.4 of the California Business and Professions Code, with**  
8 **conditions.**

10 WHEREAS, Zain Azzghayer is seeking the transfer of a Type 21 off-sale general  
11 alcoholic beverage control license for business located at 238 Sansome Street, Suite  
12 110 from 333 O'Farrell Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly  
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21  
20 off-sale general alcoholic beverage control license to Zain Azzghayer for business  
21 located at 238 Sansome Street, Suite 110 from 333 O'Farrell Street, will serve the  
22 public convenience and necessity of the people of the City and County of San  
23 Francisco.

24 Conditions: (1) Petitioners shall not permit their patrons or the general public to  
25 loiter or congregate on the sidewalks adjacent to the licensed premises; (2) The

1 petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the  
2 premises over which they have control; (3) Sales and Service of alcoholic beverages  
3 shall be permitted only between the hours of 7:00 a.m. to 12 midnight each day of the  
4 week; (4) No wine shall be sold with an alcoholic content greater than 15% by volume  
5 except for "Dinner Wine" which have been aged two years or more; (5) No beer shall be  
6 sold with an alcoholic content greater than 3.2% by volume.


