3 Resolution authorizing the Department of the Environment to accept and expend  
4 a grant in the amount of \$350,000 from the Bay Area Air Quality Management District to  
5 install a Diesel Emission Control (DEC) equipment on thirty-three (33) solid waste  
6 collection vehicles (SWCV).

8 WHEREAS, the Bay Area Air Quality Management District, in partnership with the  
9 Metropolitan Transportation Commission has awarded funds to the Department of the  
10 Environment to assist Golden Gate Disposal and Recycling Company and Sunset Scavenger  
11 Company to install a Diesel Emission Control (DEC) equipment on thirty-three (33) solid  
12 waste collection vehicles (SWCV); and,

13 WHEREAS, NOx emissions are a major component of ozone, a colorless, odorless gas  
14 that is injurious to human health when breathed; and,

15 WHEREAS, a new California Air Resources Board (CARB) regulation, which took  
16 effect in July 2004, requires all SWCV fleet to equip their trucks with the best available control  
17 technology (BACT) to reduce emissions of particulate matter (PM); and,

18 WHEREAS, the Air District and the Metropolitan Transportation Commission have  
19 made incentive funds available to encourage SWCV fleets subject to the CARB regulation to  
20 install control technology to reduce emissions of nitrogen oxides (NOx); and

21 WHEREAS, these incentive funds are available to encourage both public and private  
22 SWCV fleets to reduce NOx emissions; and,

23 WHEREAS the Department of the Environment was allowed to apply for funds on  
24 behalf of a private SWCV fleet that performs curbside solid waste collection under contract  
25 within its jurisdiction; and,


1 WHEREAS, Golden Gate Disposal and Recycling Company and Sunset Scavenger  
2 Company perform curbside solid waste collection under contract within the City and County of  
3 San Francisco; and,


4 WHEREAS, the Department of the Environment shall require that Golden Gate  
5 Disposal and Recycling Company and Sunset Scavenger Company operate the vehicles  
6 covered under this grant within the boundaries of the Air District for a minimum of five (5)  
7 years; and,


8 WHEREAS, The grant budget includes provision for indirect costs of \$5,000; now,

10 RESOLVED, that the Board of Supervisors hereby authorizes the Director of the  
11 Department of the Environment to accept and expend \$350,000 from the Bay Area Air Quality  
12 Management District to assist to assist Golden Gate Disposal and Recycling Company and  
13 Sunset Scavenger Company to install Diesel Emission Control equipment on thirty-three (33)  
14 solid waste collection vehicles (SWCV).
