3 **Resolution authorizing the Chief of Police for the City and County of San Francisco to**
4 **retroactively accept and expend grant funds made available through the California**
5 **Office of Traffic safety (OTS), a State agency, for a project entitled "Sobriety**
6 **Checkpoint Program for Local Law Enforcement Agencies."**

8 WHEREAS, The Chief of Police of the City and County of San Francisco desires to
9 undertake a certain project designated "Sobriety Checkpoint Program for Local Law
10 Enforcement Agencies", to be funded from funds made available through California office of
11 Traffic Safety, a State agency; and,

12 WHEREAS, The goal of the Sobriety Checkpoint Program is to reduce the number of
13 victims killed and injured in alcohol involved crashes; and,

14 WHEREAS, The San Francisco Police Department will conduct sobriety checkpoints
15 during a fifteen month period from December 2004 - January 2005, August 2005 – September
16 2005 and December 2005 – January 2006, in support of the "You Drink & Drive. You Lose"
17 national campaign; and,

18 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,
19 therefore, be it

20 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
21 the grant budget; and be it

22 FURTHER RESOLVED, That the Chief of Police of the City and County of San
23 Francisco is authorized on behalf of the City and County of San Francisco to retroactively
24 accept and expend continued funding for this project from the California Office of Traffic
25 Safety, a State agency and be it



FURTHER RESOLVED, That grant funds received hereunder shall not be used to supplant expenditures controlled by the Board of Supervisors




