4 **Resolution commending Yvette Stuart on the occasion of her retirement.**

5 WHEREAS, Yvette Stuart served the City and County of San Francisco for thirty years
6 in the Human Resources field, beginning as an Assistant Personnel Analyst at San Francisco
7 General Hospital and quickly advancing to Manager of the DPH Decentralized classification
8 and examination unit; and

9 WHEREAS, One of Ms. Stuart's most significant accomplishments was developing a
10 Letter of Agreement between the Departments of Public Health and Human Resources,
11 which led the way and provides an example for more than a dozen other decentralized
12 examination and classification units throughout the San Francisco by guaranteeing that the
13 staffing needs of the Health Department were fulfilled during demanding periods; and

14 WHEREAS, Yvette played a major role in many employee activities and programs
15 which dealt with challenges such as the physicians' strike of the late seventies, the nursing
16 shortage and AIDS epidemic of the early eighties, the transition of the State's Office of Mental
17 Health Social Services (OMHSS) to the Department of Health, the reorganization of the
18 Department's Mental Health Service structure, and the transition of the UCSF outpatient
19 program to SFGH control; and,

20 WHEREAS, The superiority of her work made it possible to attract and employ the best
21 and brightest in the Health profession continuing our City's role as a leader globally in
22 addressing diverse public health needs, and her impact on the quality of health care in the
23 City and County will have a lasting legacy; now, therefore, be it
