WHEREAS, The Board of Supervisors enacted resolution No. 781-04 on December 14, 2004 to establish an Arts Advisory Task Force for the purpose of offering recommendations to the Board of Supervisors and Mayor concerning was to update and/or restructure the various elements of the City's agencies, programs and policies concerning the arts in San Francisco; specifically with the emphasis on achieving three main goals:

(1) Sustaining and stabilizing community-based not-for-profit arts organizations serving, celebrating and supporting San Francisco's many diverse neighborhoods.

(2) Building upon San Francisco's strong creative workforce and existing substantial arts economy to increase employment and leverage new economic opportunities.

(3) Expanding City resources for low and moderate income housing and affordable studios and workspaces, to help retain artists in San Francisco.

2 the City's Hotel Tax allocation language, which would change the process by which hotel tax  
3 revenues are distributed to City Agencies that support and serve arts organizations and artists

5 WHEREAS, The Arts Advisory Task Force unanimously adopted a resolution to  
6 recommend to the Board of Supervisors and Mayor that no action should be taken or  
7 approved by the Board of Supervisors and the Mayor to change the City's Hotel Tax allocation  
8 language regarding the process by which hotel tax revenues are distributed to City agencies  
9 that support and serve arts organizations and artists in San Francisco, until the Arts Advisory  
10 Task Force has undertaken and completed the purposes and duties, and has submitted its  
11 final written recommendations, as set forth in Board of Supervisors Resolution No. 781-04;

13 RESOLVED, That San Francisco Board of Supervisors adopts a policy that no action

17 and completed the purposes and duties as set forth in Board of Supervisors Resolution No.

19 Supervisors; and be it

20 FURTHER RESOVLED, That the Board of Supervisors a adopt a policy to include  
21 funding in the City's budget for fiscal year 2005-2006 for the purposes of supporting and  
22 serving arts organizations and artists in San Francisco consistent with the goals set for the  
23 Arts Advisory Task Force; and be it

24 FURTHER RESOLVED, That the Board of Supervisors urges the Mayor to adopt a  
25 similar policy.




