[Creation of Motorcycle Only Parking Zones.]

Resolution designating motorcycle only parking zones at curb spaces fronting the properties of 1015 Irving Street, 1365 9th Avenue, 1367 9th Avenue, 1300 8th Avenue, 1299 8th Avenue, and 1271 9th Avenue on a twenty-four hour, seven day a week basis and requiring appropriate signage.

WHEREAS, The Office of the Legislative Analyst found that motorcycle registrations are among the highest in the city in District 5; and

WHEREAS, The Office of the Legislative Analyst found that the number of motorcycles in the City is increasing faster than that of automobiles; and

WHEREAS, The Office of the Legislative Analyst found that the number of legal and safe motorcycle parking spaces is very limited; and

WHEREAS, There is only enough citywide motorcycle parking available for one in ten vehicles registered in the City; and

WHEREAS, Motorcyclists help ease density and reduce traffic congestion, thereby helping to make the city more livable; and

WHEREAS, Motorcycles are a more space efficient means of transportation, needing less than one-fifth the space of an automobile, making them an attractive alternative in a land-sparse city; and

WHEREAS, With more motorcycle parking available, motorcyclists will be less likely to park on sidewalks, thereby increasing pedestrian safety; and

WHEREAS, With more motorcycle parking available, motorcyclists will be less likely to take on-street parking from automobiles; and

1 WHEREAS, With designated motorcycle parking available, motorcyclists will have a
2 safer, legal place to park with less likelihood of damage from car bumpers; and

3 WHEREAS, Curb space fronting the properties located at 1015 Irving Street, 1365 9th
4 Avenue, 1367 9th Avenue, 1300 8th Avenue, 1299 8th Avenue, and 1271 9th Avenue is three
5 feet or more in length but too small for the parking of automobiles; now, therefore, be it

6 RESOLVED, That the Board of Supervisors designates exclusive motorcycle only
7 parking zones at curb spaces fronting the properties of 1015 Irving Street, 1365 9th Avenue,
8 1367 9th Avenue, 1300 8th Avenue, 1299 8th Avenue, and 1271 9th Avenue on a twenty-four
9 hour, seven day a week basis; and, be it

10 FURTHER RESOLVED, That the Department of Parking and Traffic shall install
11 appropriate signage designating the motorcycle only parking zones.


