11 WHEREAS, The City Planning Department has verified that the area is properly  
12 zoned; and

13 WHEREAS, The Police Department recommends that the liquor license  
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business  
16 and Professions Code, the Board of Supervisors of the City and County of San  
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42  
18 on-sale beer and wine license, to Mark A. Dirsa for WINE, located at Two Embarcadero  
19 Center – Street Level will serve the public convenience and necessity of the people of  
20 the City and County of San Francisco.

21 Conditions: (1) Petitioners shall not permit their patrons or the general public to  
22 loiter or congregate on the sidewalks adjacent to the licensed premises; (2) The  
23 petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the  
24 premises over which they have control; (3) Sales and service of alcoholic beverages

1 shall be permitted only between the hours of 10:00 a.m. and 12:00 midnight Sunday  
2 through Thursday and 10:00 a.m. and 1:00 a.m. Friday through Saturday.
