12 WHEREAS, The Foundation was the nation's first foundation dedicated to the lesbian,
13 gay, bisexual and transgender community; and,

14 WHEREAS, The Foundation has provided leadership to successfully increase the
15 acceptance of LGBT people; and,

16 WHEREAS, The Foundation has created strong and sophisticated organizations
17 meeting the needs, advancing the rights, and celebrating the lives of LGBT people; and,

18 WHEREAS, The Foundation has become best known for its ability to identify emerging
19 issues and organizations and channel grants to fledgling groups and visionary activists; and,

20 WHEREAS, The Foundation has increased the quality and quantity of LGBT
21 philanthropy through the establishment of one of the first and largest LGBT-based donor
22 advised funds program on how to give more effectively, and;

23 WHEREAS, The Foundation serves as an advocate for the LGBT community to raise
24 awareness and has helped bring more than \$ 1 million to the LGBT community from non-
25 LGBT sources; now, therefore be it
